

Judith Strawbridge is the Deputy Head (Education) of the School of Pharmacy and Biomolecular Sciences, RCSI. She has extensive leadership in designing, delivering, assessing and evaluating teaching and learning for the healthcare professions.

She graduated with a 1st Class Honours degree in Pharmacy from the Queen's

University of Belfast in 1993 and undertook her pre-registration training in Addenbrooke's Hospital, Cambridge in 1994. She worked in hospital practice in Ireland and completed her MSc in Hospital Pharmacy in 1997 from Trinity College Dublin. Judith transitioned into academia in 2001 when the School of Pharmacy opened in RCSI. She completed her PhD in Pharmacy Education in 2011.

Inspired by her clinical experience and educational research, she remains passionate about providing students with the optimal, patient-centred, education for professional practice. She advocated for the involvement of patients in educational delivery from the outset, and has deepened this involvement to include patients and the public in curriculum design and academic governance. She is the RCSI lead for Patient and Public Engagement, and responsible for RCSI's strategic aim to deepen patient engagement across both education and research. She is involved in Patient and Public Involvement (PPI) at a National level as a member of IPPOSI's Education and Training Advisory Group and the National PPI Ignite Working Group on PPI in Undergraduate and Postgraduate Education.



#### Professor. Derek Stewart

Professor of Clinical Pharmacy and Practice at the College of Pharmacy. BSc (Pharm), MSc (Clinical Pharmacy)(U of Aberdeen), PhD (Robert Gordon U, UK)

He graduated with a first class honours B.Sc. Pharmacy from Robert Gordon Institute of Technology in Scotland in 1987. He obtained a M.Sc. in Clinical Pharmacology from the University of Aberdeen in Scotland in 1990 and a Ph.D. from Robert Gordon University in Scotland in 1998. Prior to his appointment at Qatar University he was Professor of Pharmacy Practice at the School of Pharmacy and Life Sciences, Robert Gordon University, Scotland.

He has published over 180 peer-reviewed research papers, supervised 20 PhD students to completion and, while in the UK, secured research income of around £3 million. In 2011, he was awarded the Royal Pharmaceutical Society Practice Research Award for his outstanding contribution to practice research. He is an award winning executive editor of the British Journal of Clinical Pharmacology and a member of the editorial board of the International Journal of Clinical Pharmacy.
